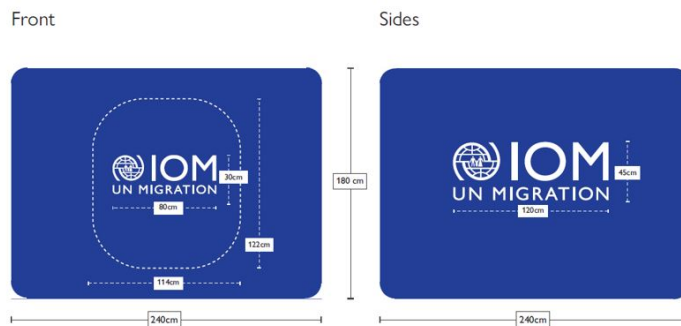
Indoor privacy partition is for indoor use as a partition to increase privacy in collective centre or other settings. It is not for use outdoors as it does not provide protection from any elements.

The partition is made of polyester with a steel wire frame. It has 2 doors on each side, allowing it to be set up in a modular arrangement. There is mosquito meshing on the doors and roof (the roof is only mosquito meshing with no polyester layer).
